Feedback from CGL (Louise Martin)

As a member of the professional panel, I found the opportunity to hear the service user panel's impressions of the candidates invaluable. I started the conversation feeling quite uncertain as to the correct choice of candidate, and the process of discussion really helped to evolve my thinking to a decision I felt confident with. The service users who contributed brought a great deal of careful thought and expertise to a really difficult decision and having this additional different lens on the candidates helped to clarify and shape my own thinking. Each person on the SU panel brought different views, which crystallised some of my more



unformed thoughts. Christy, Megan, and Paul each said a number of things that resonated with me in this way; in particular (and amongst many helpful contributions) Paul made an excellent point relating to interview style, Christy about the candidates' abilities to manage different contexts, and Megan really clearly articulated the hesitations I think we all felt about the choice in front of us. Having a service user panel as part of the interview process was enriching and this experience gives me confidence to do this again for future interviews. 


